



# SAN DIEGO BOTANIC GARDEN

## PHOTO/VIDEO/FILM FEES

San Diego Botanic Garden is a wonderful place for photography, videography and filming. A permit is required for any photo/video/film shoots in the Garden. This includes any individual who intends to use images taken in the Garden for portraits, commercial, professional, promotional, advertising, marketing, social media or any other purposes, where payment of any kind is received by the individual for images taken at the Garden. Photographers, videographers, artists or individuals must complete an SDBG Photo Agreement, a Hold Harmless Agreement and submit the applicable fee payment. In all commercial instances, Proof of Liability Insurance is also required.

***Without payment of the applicable fees and SDBG approval, it is strictly forbidden to use or sell images taken in the Garden. Use of photos/videos without payment and approval can result in the Garden taking legal action.***

**Reservations.** Contact Ashley Grable, Communications and External Relations Manager at (760) 688-8350 or [agrabl@sdbgarden.org](mailto:agrabl@sdbgarden.org) with type of session and date(s)/time(s) desired for session. ***Reservations and fees must be approved and paid 5 business days in advance of agreed upon shoot date.*** Time restrictions may apply if other events are scheduled in the Garden on the date/time requested. The Garden reserves the right to deny any photo/video/film shoot requests at any time.

**Fees.** San Diego Botanic Garden is a 501(c)(3) organization. Fees collected are used to support the care and preservation of the Garden. Fees include a full buy out.

Wedding, engagement & family portraits still photography 6 paid admissions included with fee (additional guests charged regular admission prices on top of fees) *No photo fees required for weddings held at SDBG	* \$300 per session (minimum of 3 hours between 9 am - 5 pm) <i>There is no discounted rate for using less than 3 hours for the photo shoot.</i> <i>Additional fees may be incurred for hours outside of normal business hours.</i>  * Exceeding 3 hours will result in a \$150 charge at the beginning of each additional hour. * Hold Harmless Agreement required.

<p>Commercial/professional still photography</p> <p>6 paid admissions included with fee (additional guests/crew members will be charged regular admission prices on top of photo fees)</p>	<p>*\$1,000 per day (8 hours from 9 am - 5 pm) * \$600 per half day (4 hours from 9 am - 5 pm) <i>There is no discounted rate for using less than 4 hours for the photo shoot.</i> <i>Additional fees may be incurred for hours outside of normal business hours.</i></p> <p><i>Additional fees may be required if photography/filming requires closure of Garden buildings or areas critical to the public or if special staging is required. In such cases, additional fees may be negotiated on a case-by-case basis.</i></p> <p>* Exceeding scheduled hours will result in a \$300 charge at the beginning of each additional hour. * Proof of Liability Insurance (\$1 million) &amp; Hold Harmless Agreement required.</p>
<p>Commercial video &amp; movie production crews</p> <p>10 paid admissions included with fee (additional talent/crew members will be charged an additional fee depending upon number of individuals in crew)</p>	<p>*\$2,000 per day (8 hours from 9 am - 5 pm) * \$1,100 per half day (4 hours from 9 am - 5 pm) <i>There is no discounted rate for using less than 4 hours for the video shoot.</i> <i>Additional fees may be incurred for hours outside of normal business hours.</i></p> <p><i>Additional fees may be required if photography/filming requires closure of Garden buildings or areas critical to the public or if special staging is required. In such cases, additional fees may be negotiated on a case-by-case basis.</i></p> <p>*Exceeding scheduled hours will result in a \$500 charge at the beginning of each additional hour. *Proof of Liability Insurance (\$1 million) &amp; Hold Harmless Agreement required.</p>
